TERMS & CONDITIONS

1. Promoter

This promotion is organised by Sheerline, a trading division of Garnalex Limited ("Sheerline", "we", "us" or "our").

2. Eligibility

- This promotion is open to UK-based trade customers, fabricators and installers only.
- Entries from members of the general public or homeowners are not eligible.
- Entrants must be aged 18 or over.
- Employees of Sheerline/Garnalex Limited, their immediate families and anyone directly involved in administering the promotion are not eligible to enter.

3. Promotion Period

The promotion opens on 21 September 2026.

The promotion will remain open until further notice and may be closed at any time. Sheerline will communicate when submissions are no longer being accepted via social media channels.

4. How to Enter

To enter, eligible participants must:

- Complete the online submission form via the dedicated Sheerline landing page.
- Upload quality photographs of an eligible S1 Roof Lantern installation.
- Provide the information requested on the submission form.
- Confirm that they have the necessary permission to submit the photographs.

5. Eligible Products

- Only photographs featuring a Sheerline S1 aluminium roof lantern will qualify.
- Submitted images must be genuine photographs of actual Sheerline S1 aluminium roof lantern installations.
- AI-generated, AI-created or digitally generated images will not be accepted.
- Images that have been materially altered or manipulated to misrepresent an S1 installation may be rejected.
- Sheerline reserves the right to request additional information or evidence to verify an installation where necessary.
- Photographs of other Sheerline products, other roof lantern systems or products manufactured by other companies will not qualify.
- The S1 must be identifiable in the submitted photographs.
- Sheerline reserves the right to reject any submission where the product cannot be verified as a Sheerline S1 aluminium roof lantern.

6. Entry Limit

- A maximum of three (3) separate entries per company or individual is permitted.
- Each entry must relate to a separate S1 installation.
- Multiple photographs may be submitted as part of a single entry where requested by the submission form.
- Submitting multiple entries for the same installation will not result in additional vouchers.
- Sheerline reserves the right to disqualify duplicate, fraudulent or otherwise invalid entries.
